

Register of Business Interests 2021/22

Academy trusts must have a register of relevant business and pecuniary interests of their members, trustees and local governors. The interests of all local governors of academies within a multi-academy trust (MAT) and of senior staff should also be recorded. The register must be published online, and must include details of:

- Directorships, partnerships and employments with businesses
- Trusteeships and governorships at other educational institutions or charities.

For each interest, the academy trust must record the name of the business, nature of the business, nature of the interest and date it began. The Academies Financial handbook says the register must be kept up to date through regular review.

The register must also include any material interests arising from close family relationships between the academy trust's members, trustees or local governors, and relationships between members, trustees or local governors and employees.

The Department for Education (DfE) advises that the above requirements apply to both a trust's copy of the register and the details that the trust publishes online.

Beyond the statutory requirements outlined above, whether something should be declared and recorded as an interest is largely up to each individual's discretion. However, if there is any doubt as to whether something should be recorded as an interest, it is best for the Member, Trustee or Local Governor to declare it.

For example, it may be best to declare:

- Membership of any professional bodies
- Any gifts or hospitality offered to trustees or local governors
- Contracts held by trustees or local governors that involve the school

As well as declaring any such involvement on the register of interests, Members, Trustees and Local Governors should be given the opportunity to declare interests of this sort before meetings, so they can withdraw from the discussion of relevant items of business.

All trustees and Members have completed the Declaration for Fit and Proper Persons
